TERMS AND CONDITIONS

- 1. Payment terms are strictly within 25 days from date of statement.
- 2. The Applicant agrees that should any portion of an invoice be in dispute, the Applicant undertakes to pay the undisputed amount of the invoice to the agreed terms of credit allowed in terms of this agreement.
- 3. Uber Optical shall be entitled to charge interest on all overdue amounts at a compound rate of 3% per annum above the prime bank overdraft rate as charged by Uber Optical's bankers.
- 4. The Applicant agrees that in the event of its default in any respect whatsoever towards Uber Optical, Uber Optical will be entitled to place the Applicants account on hold and withhold any further supply without any notice notwithstanding that the Applicant may have placed an order prior rot the account being put on hold.
- 5. All the goods remain the sole and absolute property of Uber Optical until full payment has been received by Uber Optical in respect of any goods supplied to the Applicant.
- 6. In the event of Uber Optical instructing its attorneys to collect any amounts, all legal fees and collection charges and all other costs incurred will be borne by the Applicant on an attorney and own client scale.
- 7. It is up to the discretion of Uber Optical whether to accept the return of goods for credit from the Applicant.
- 8. If the goods were correctly supplied by Uber Optical and were not faulty or subject to any claim, then Uber Optical will be entitled without the necessity of any further agreement to claim a handling fee of 20% of the invoice price of the goods returned should the goods not be returned in good order and in the original packaging.
- 9. The applicant agrees to the Goods Return Policy as stated on the Uber Optical form.
- 10. The credit facilities may be withdrawn by Uber Optical at any time without prior notice.
- 11. The Applicant/s choose the addresses provided by it/them in this Credit Application as *domicilium citandi et executandi* for the purposes of service of all legal notices and process arising out of this Credit Application.
- 12. In the event that legal action needs to be taken for any sums outstanding in terms of this Credit Application, the Applicant Consents to the Jurisdiction of the Cape Town Magistrates court.
- 13. Both the Applicant and Uber Optical confirm that the Credit Application constitutes the entire agreement between the parties; any amendment, cession of rights by the Applicant, or any other form of variation of this agreement will be of no force and effect unless reduced by writing and signed by all of the parties.
